Clint Miller informed the board and guests of the passing of Coach Danny Dick. Followed by a moment of silence.

Bo Helms moved to approve the agenda, seconded by Aaron Diggs. 6-0, motion carried.

Karla Pettigrew moved to approve the consent agenda, seconded by Patsy Reed. 6-0, motion carried.

Under recognition Dr. Terry Robinson recognized Ms. Elizabeth Sutton who donated school supplies to the District. Dr. Robinson also recognized Mr. and Mrs. Scott Jurgensmeyer and son, Jet, who donated musical instruments to the band.

Under presentations Mr. Brian Hill introduced new District staff to the board and welcomed them to the District. Mrs. Jennifer Wellman and Mr. Shawn Harris spoke about virtual learning.

Under program evaluation Mrs. Lori Stoll talked about what Opa! plans to do this school year concerning safety, meal selection and delivery. Mrs. Stoll mentioned that over 40,000 meals were served during the COVID school closure.

Also under program evaluation Dean Bishop gave the maintenance report. Mr. Bishop also reported on preparations that the maintenance staff have completed this summer. With the addition of the middle school, there is a need for more lockers.

Bo Helms made a motion to approve up to \$5,000 for lockers for the middle school, seconded by Kent Fischer. 6-0, motion carried.

Mrs. Genee Fischer presented the board with the 2020 yearbooks.

Under the superintendent report Dr. Terry Robinson talked about how the official count of the school bond election remained the same. Dr. Robinson also went over the facilities plan review. Dr. Robinson mentioned that he is currently working on eight different grants related to COVID-19 expenses.

The administrators presented a slideshow covering the school reopening plans for the upcoming school year.

Under administrator reports Mrs. Leeanna Meador, Mr. Kelly Kohler, Mr. Jason Culpepper and Ms. Nancy Thomas were available to answer questions regarding their reports.

Under new business Dr. Robinson offered to the board the consideration of new ballot language for a bond issue. Clint Miller suggested a work session. New bond language would need to be made by August 25th, in order to be placed on the ballot. A budget work session is scheduled for Thursday, August 20, 2020 at 6 pm.

There was no action taken on the disposition of the old central office.

Craig Wolf moved to adjourn to executive session pursuant to Section 610.021 (2), (3), (11) and (12) RSMo, with the inclusion of the superintendent, Mr. Kelly Kohler and Ms. Nancy Thomas, seconded by 6-0. Roll call vote: Unanimous. Following a short recess the board entered into executive session at 8:28 pm.
