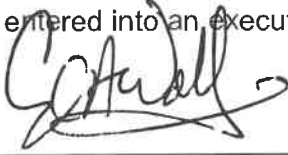
Under administrator reports Mrs. Leeanna Meador and Ms. Nancy Thomas were available to answer questions regarding their reports.
