Prior to the regular meeting: *Correspondence to the Board: Thank you letters and cards Craig Wolf called the regular meeting to order followed by the pledge of allegiance.

Stephanie Oldham made a motion to approve the agenda seconded by Aaron Diggs, 7-0 motion carried.

Bo Helms made a motion to approve the consent agenda a-i, seconded by Amanda Pettigrew, 7-0 motion carried.

Aaron Diggs abstained from check #47979. The consent agenda contained the following.

Under Presentation Deann Lawson, CTA President introduced the new teachers for the 2023-2024 school year.

Steven Combs the Harrisburg Superintendent presented information about the new conference opportunity for Tipton R-Vi. The conference would consist of South Callaway, Linn, New Bloomfield, Russellville, Eugene, Fayette, Harrisburg, and Tipton.

Under the superintendent's report, Doctor Terry Robinson presented information on a grant for a school alert system through Raptor Technology. This would be an alert system that would come through on a cell phone. He briefly touched on the assessed valuation of our area and the impact that will make on school funding. Dr. Robinson then introduced Mrs. Genee Fischer, the yearbook advisor. Mrs. Fischer presented the board of education with a 22-23 yearbook.

Under administrator reports Mrs. Leeanna Meador, Mrs. Ashlee Pettigrew, Mr. Jason Culpepper, and Ms. Nancy Thomas were available to answer questions regarding their reports.

There was no old business to discuss.

Under new business, a discussion was held concerning the move to a new conference.

Bo Helms made a motion to move to the new conference, seconded by Ashley Kliethermes, 7-0 motion carried.

Doctor Terry Robinson reviewed the information regarding changing days off for employees to PTO (paid time off). The new policy would include 12 PTO days for 9-month employees, 13 for 10 months, 14 for 11 months, and 15 for 12 months. It would also reduce some costs by eliminating the leave paid out for personnel leaving prior to six years of service and raising the number of days from 90 to 100 before the leave is paid out annually. The rate for unused leave would go from \$50/day to \$75/day.

Bo Helms made a motion to approve PTO, seconded by Ashley Kliethermes 7-0 motion carried.

A discussion was held on raising substitute teacher pay. A recommendation to raise pay by 5% across the board was made by Dr. Robinson. This would mean that the new substitute teacher's daily rate would be \$115 (long-term \$165), and a substitute aide, secretary, or nurse would make \$100 a day.

Bo Helms made a motion to approve substitute pay, seconded by Ashley Kliethermes, 7-0 motion carried.

Bo Helms moved to adjourn to executive session pursuant to section **610.021(3)**, seconded by Aaron Diggs. Roll call vote was taken unanimously passing with the inclusion of Dr. Robinson, Jason Culpepper, and Nancy Thomas
