Craig Wolf called the regular meeting to order followed by the pledge of allegiance.

Bo Helms made a motion to approve the agenda seconded by Aaron Diggs, 7-0 motion carried.

Under Presentation

3MT-Jim Wright, Lois Dunnaway, and Sue Kohler were present from the 3MT to present information on their organization. They asked the board to consider housing the mission team while they provided needed upkeep and maintenance services to members of the community. The organization would also provide some needed maintenance services to the Tipton R-VI School District during their stay. The group would consist of 70 to 80 middle school/high school-aged youth and advisors. They would need approximately 5 rooms for girls and 5 rooms for boys and use of the cafeteria. 3MT would need access to the building on a Friday (set-up day) through the following Saturday.

First Student Transportation Services: John Jacob gave a bus route analysis and recommendations for the 2023-2024 school year. He stated that we currently have 197 riders, most of those being from the elementary. First Student is fully staffed at this time and routes seem to be working well.

Under the superintendent's report, Doctor Terry Robinson presented information on current project updates.

Under administrator reports Mrs. Leeanna Meador, Mrs. Ashlee Pettigrew, Mr. Jason Culpepper, and Ms. Nancy Thomas were available to answer questions regarding their reports.

Under new business,

Doctor Terry Robinson recommended the board approve the bus routes for the 2023-2024 school year.


Aaron Diggs made a motion to approve bus routes, seconded by Ashley Kliethermes, and a 7-0 motion was carried.

Bo Helms made a motion to approve 3MT to use the school building June 22nd-29th, seconded by Ashley Kliethermes, 7-0 motion carried.

Bo Helms moved to adjourn the school board meeting, seconded by Kelly Kohler. The meeting was unanimously adjourned by a roll call vote at 6:47 PM.
